Aiming at intellectual and social upliftment of the female students, the cell stands for facilitating women's empowerment through guest lectures, seminars, awareness programmes and other welfare activities.

### **Objectives:**

The objectives of the Committee are:

- ✓ Prevent discrimination and sexual harassment against women, by promoting gender amity among students and employees
- ✓ Make recommendations to the Director for changes/ elaborations in the Rules for students in the Prospectus and the Bye-Laws, to make them gender just and to lay down procedures for the prohibition, resolution, settlement and prosecution of acts of discrimination and sexual harassment against women, by the students and the employees
- ✓ Deal with cases of discrimination and sexual harassment against women, in a time bound manner, aiming at ensuring support services to the victimized and termination of the harassment
- ✓ Recommend appropriate punitive action against the guilty party to the Director.

## **Periodicity And Attendance At Meetings:**

- a. The Women Welfare / Sexual Harassment Eradication Cell will meet at least once in six months. However, if necessary, it may meet more frequently at the instance of the coordinator or at the request of the other members to discuss the various issues identified.
- b. At least four members of the Women Welfare/Sexual Harassment Eradication Cell shall be present at a meeting.

# **Procedures for Approaching Committee:**

Here it should be noted that according to the Supreme Court guideline Sexual harassment can be defined as "unwelcome" sexually determined behaviour (whether directly or by implication) as:

- ✓ Physical contact and advances
- ✓ Demand or request for sexual favours
- ✓ Sexually coloured remarks
- ✓ Showing pornography and
- ✓ Other unwelcome physical, verbal or non-verbal conduct of a sexual nature.

## The following types of sexual harassment are covered by the committee:

- ✓ Eve-teasing
- ✓ Unsavoury remarks
- ✓ Jokes causing or likely to cause awkwardness or embarrassment,
- ✓ Innuendos and taunts
- ✓ Gender based insults or sexist remarks
- ✓ Unwelcome sexual overtone in any manner such as over telephone (obnoxious telephone calls)
- ✓ Touching or brushing against any part of the body
- ✓ Displaying pornographic or other offensive or derogatory pictures, cartoons, pamphlets
- ✓ Forcible physical touch or molestation
- ✓ Physical confinement against one's will and any other act likely to violate one's privacy

## **Roles and responsibilities of Student Representatives:**

Representative in true sense is standing for others. Student representative of WEC represents and stands for all the girl students of her class. Here are the responsibilities of the student representative. They should be willing:

- ✓ To spread the objectives of WEC among the girl students.
