

# **RULES AND REGULATIONS**

1. All persons who has completed the age of 18 years and abide by all the Aims and Objectives and the Rules and Regulations of the Association is eligible for the membership.

2. Any person member / person as stated above may be admitted by the General Body as a member of the Association on receipt of written applications along with an admission fee of Rs.100/- (Rupees one hundred only) and the Executive body is vested with absolute powers of admission or refusal of admission without assigning any reason what so ever. Every member shall pay Rs.50/-(RUPEES FIFTY ONLY) per month towards subscription. Any member who fails to pay continuously 3 times, his membership will be forgone, he shall again apply for his membership on written application along with an admission fee of Rs:100/-(Rupees hundred only). If any member fails to attend three subsequent meetings he himself forego his membership. If any member has dues in his credit as on the date of election, he has no right to vote.

# GENERAL BODY AND ITS FUNCTIONS

1) The General body meeting will be held once in a year ordinarily in the month of April to consider the Financial Statements of the Association and all the matters forwarded by the Executive Body and also for renewal of the Association from the Registrar of Societies.

- 2) The General body shall elect the Executive Body to hold their office for a period of three years.
- 3) All the resolutions are passed by 3/5<sup>th</sup> of General Body and in case in tie, the President shall have a casting Vote in additional to his own.
- 4) There must be a General body Members as per Societies Registration Act 35 of 2001.

# EXECUTIVE BODY / MANAGING BODY / OFFICE BEARERS AND ITS FUNCTIONS:

a) The Executive Body consists of 7 members i.e. .

Total	7	(Seven members)

- b) The Executive Body will be elected from the General Body and they hold office for a period of three years or until their successors are elected.
- c) The Managing Committee can carry on certain actions in case of emergency without priorapproval of the General Body and later on put before the General Body for ratification.
- d) The Managing Committee shall prepare financial statement showing the income and expenditure for the year and place it before the General Body for approval in the month of April.
- e) All the activities of the Committee are to be reported to the General Body by the Managing Body and whenever necessary approval by a vote shall be taken and resolutions are deemed to be carried out by a majority.
- f) The Managing Committee shall appoint Auditor, Teaching Staff of Highly Educational Standards, and those who possess international Standards if necessary.
- g) The Executive Body shall meet once in three months. Under the special circumstances if the Executive Body members of them or the General Body Members by written requisition the Executive or General Body shall be conveyed within 7 days. The emergency meeting of the Executive Body shall be conveyed by giving written notice within 3 days for taking important decisions.

# FUNCTIONS OF THE EXECUTIVE BODY AND OFFICE BEARERS

#### PRESIDENT:

The President shall convey all the meetings and will consolidate the proceedings of all meetings and work for the success of the society. The president shall act as per the advice of the other Executive Body Members and call for meetings with the help of and the advice of the other Executive Body Members. He shall have power to incur expenditure up to Rs.1000/- or to grant in aid of others in emergency at Rs.500/- He shall be the person to be used of any level matters pertaining to the organization. He presides over all the meetings of both the General Body and Executive Body. He can supervise all the branches of the society.

#### **VICE-PRESIDENT:**

The Vice-president shall exercise his powers on par with the President as and when the President is not able to exercise her powers due to absence in the interest of Society. The Vice-President shall operate the work of the President on written Notice.

# **GENERAL SECRETARY**

He shall conduct the meetings. He shall executive the works and shall introduce resolutions of the various organizations and make correspondent on all matters. He shall be the custodian of all records and books of library and also have power to ensure administration and also have the powers to meet the all the dignitaries and to maintain all accounts. He can sanction expenditure to the extent of Rs.500/- at a time in the year subject to the subsequent sanction of the governing Body. He shall look after the day to administration and discipline of the Association. He shall operate the Bank Account alone.

# **JOINT -SECRETARY:**

The Joint-Secretary shall exercise her powers on par with the General Secretary as and when the General Secretary is not able to exercise her powers for the interest of the Society. During the absence of the General Secretary, the Joint Secretary shall operate the work of the General Secretary on written notice.

#### TREASURER:

The Treasurer shall maintain all accounts pertaining to the Society in the matter of expenditure and collections under the supervision of the President and General Secretary. She shall deposit the money in the Bank or collect money from the General Body Members or funds from the public for the development of the Society. She shall be important person to keep all accounts with up to date maintenance. The Treasurer shall keep a reserve fund of Rs.500/- in his custody with the approval of the President and General Secretary for miscellaneous expenses.

# E.C. MEMBERS:

The Members of Executive Body of the society shall extend their help for the development of the Association and give full assistance to other Executive Body Members.

#### **SUITS:**

The Society may sue or be sued by the name of the President only.

#### **GENERAL**:

- a. The minutes of every meeting shall be recorded in a book specially kept for the purpose and the same shall be signed by the President at the end of the meeting and kept the book in the office only.
- b. The Executive Body may remove the primary membership of any member from its rolls with 3/5<sup>th</sup> majority of members present, when the activities of such person/ persons are found determinate to the interest of the Society.
- c. The General Body shall have the power to add/alter/replace/change/ delete any of the above article/articles, any objects of the Association with 3/5<sup>th</sup> majority of the total eligible members in a meeting specially convened for the purpose.
- d. The funds shall be spent only for the attainment of the Objectives of the Society and no portion thereof shall be paid or transferred directly or indirectly to any of its members through any means.

# **QUORUM:**

3/5<sup>th</sup> of the total members for General Body Meeting. There shall be President and Secretary & Correspondent to call for Executive and General Body meetings.

# **AMENDMENTS:**

No amendment or alternation shall be made to the Society unless is voted by 3/5<sup>th</sup> of members present at a meeting convened for the purpose and confirmed by the 3/5<sup>th</sup> of the members present at a second Special meeting at an interval of one month after the former meeting.

The General Body shall have powers to add, alter or delete rules to the existing rules subject to the restrictions contained in Sec.8 of the Societies Registration Act 35 of 2001 by 3/5<sup>th</sup> majority of General body members.

**FUNDS:** 

The funds of the Society shall be operated by General Secretary alone. The funds of the Society shall be spent only for the attainment of the Objectives of the society and no portion thereof shall be transferred directly or indirectly to any of its members through any means.

# The society may raise funds on any of the following sources:

a) By means of National or International donations.

b) Loans from different Agencies.

c) Grants, Margin moneys and subsidies from State and Central Governments and any other corporations;

d) Grant from International Donor Agencies etc.

# **DISSOLUTION:**

On the recommendations of the Executive Committee, the Society may be dissolved at any time by the General Body in its meetings where in a resolution supported by 3/5<sup>th</sup> of the members of the rolls as on that date is passed to that effect.

In case the Society has to be wind up the properties and funds of the Society that will remain after full satisfaction of the liabilities of the Association will be transferred or paid to some other institution of the General Body of the Society supported by  $3/5^{th}$  of the General Body members on the rolls on that date.

# **BANK ACCOUNT:**

The Bank A/c should be in the name of the Society in any Nationalized/ scheduled Bank and shall be operated by the General Secretary alone.

# **GENERAL:**

All the provisions of the societies Registration Act 35 of 2001 not specifically mentioned herein shall also apply to this.
