- Takes affidavits from the students and parents regarding Ragging during the Admission.
- Arranges counseling and guidance programs arranged for the fresher's and parents regarding ragging.
- Canvases about anti-ragging in the forms of Flexes, Posters and Boards in college premises and surrounding areas where there is a chance of ragging.
- Provides helpline details inside and outside college premises.
- Resolves the complaint received from the victim.

**Responsibility:**

- To receive any grievance/complaint from student regarding harassment.
- To investigate the case based on the above mentioned complaints related to harassment within 10 working days.
- To conduct a systematic enquiry on receiving any complaints from aggrieved students and submit a detailed report to the undersigned for suitable action.

- Informed all the committee members to visit the college campus and hostel premises.












